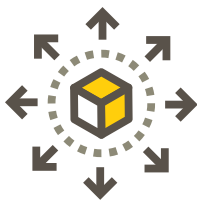


These tools are available to staffing companies as soon as they register. After they earn the mark, they maintain access to program resources and updated materials.

## How the Program Works



After your company registers online for the Safety Standard of Excellence program, you will learn more about the assessment process and how your company size plays a role in that assessment. You will receive a customized program agreement, which includes a plan of execution as well as fees associated with safety assessments. There's also an initial registration fee.

Once registered, your team can access a wide range of resources available through a convenient online portal. These resources—including sample checklists and best practices—help your company prepare for the safety assessment process.

Next, your company schedules an on-site safety assessment, during which a National Safety Council consultant reviews safety-related policies and procedures, and compares those findings against program best practices.

## What to Expect **After the Assessment**

After the assessment is complete, your team will participate in a consultation to review the findings. You'll receive a report that includes assessment details, scores, and opportunities for safety improvements.

If your company meets the program's requirements, then you earn the Safety Standard of Excellence mark. You'll receive marketing tools—including a press release and social media content—and a customized logo featuring your company's name.
