If you do not have an ereader on your computer, you will first need to download one. ASA does not recommend any ereader software in particular, though there are many free options available.

- If you have a Kindle, download the Kindle PC application. Then save the MOBI version of the ebook.
- If you are using another application, download [IceCream Ebook Reader](#), [Nook Reading App](#), [Kobo Desktop](#), or another application. Then save the EPUB version of the ebook.

Once the ereader software is downloaded on your desktop, open the MOBI or EPUB file and you will be able to view the ebook.






**STEP THREE: Once the eReader is downloaded, open the application.**
